80th ANNUAL MEETING

The University of Nebraska Federal Credit Union cordially invites you to attend our 80th Annual Meeting. The Annual Meeting is set for Wednesday, April 4, 2018 at 6:00 p.m. at the UNL Willa Cather Dining Complex located at 530 N. 17th Street. The evening includes a nice buffet dinner followed by a business meeting and chances to win prizes. There is no cost to attend the Annual Meeting. Election procedures are as follows

The nominations committee has submitted a list of four candidates. We have four positions open on the Board and four candidates, therefore, the credit union will not be holding an election by ballot this year. Additionally, the credit union will not accept nominations from the floor at the Annual Meeting.

Additional nominations for vacancies on the Board of Directors may be made by petition signed by one percent of the credit union members. Nominees by petition must submit a statement of qualifications and biographical data with their petition, as well as a signed certificate stating they are agreeable to the nomination and will serve if elected to the office. The closing date for receiving nominations by petition is February 1, 2018.

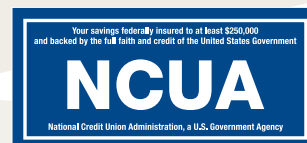
