banking options we are bringing to the Kearney market. The credit union also had advertisements in *The Hub*,

Patti lives in Kearney with her husband. They have three grown children and three grandchildren.



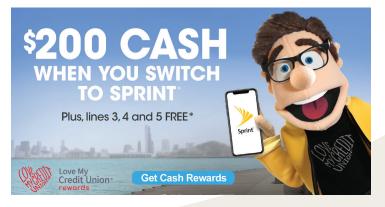

Credit union receives silver recognition for recycling

On June 27, the credit union received word that we achieved a leadership level of silver from the City of Lincoln, Solid Waste Management Division for recycling 40-59% of our commercial waste generated. According to our certificate, the credit union diverts 58% of generated refuse through recycling efforts.

The credit union completed an online application that looked at the number of waste containers, recycling containers and composting containers. We needed to indicate how much we are recycling and how much we are putting into our trash containers.

Once the application was completed we had an

on-site visit from Ryan Becker, an Environmental Health Educator from Solid Waste Management. Representatives from the credit union walked around the downtown location discussing changes that had been made to increase our recycling. The credit union eliminated plastic water bottles by installing a water bottle filler on our water fountains and switched from styrofoam plates and cups to a biodegradeable paper option.

The credit union plans to apply to have the Lincoln East branch evaluated for this recognition. We are discussing ways we can continue to improve so that the credit union can move into the gold level.
