NUFCU named a Best Credit Union in Nebraska by Forbes

In their first-ever ranking of "Best-In-State Banks and Credit Unions," your credit union was ranked among the best credit unions in Nebraska - scoring above all the banks in Nebraska!

On June 28, 2018 Forbes posted an article online entitled "The Best Banks And Credit Unions in Every State." The University of Nebraska Federal Credit Union is proud to have made the list as one of the top credit unions in Nebraska.

With the understanding that the number of banks and credit unions has decreased by a total of 70% in the last 35 years, *Forbes* partnered with market research firm *Statista*. This partnership produced the first-ever look at the Best-In-State Banks and Credit Unions.

The unique feature of this research is that instead of gauging the Balance Sheets and Profit and Loss statements of financial institutions, which Forbes does on a regular basis, *Statista* surveyed more than 25,000 customers in the U.S. for their opinions on their current and former banking relationships. Banks and credit unions were rated on overall recommendation (30%) and satisfaction (30%), as well as five subdimensions (trust, terms and conditions, branch services, digital services and financial advice.)

When the research was completed only 2.4% of U.S. financial institutions made the final cut. And credit unions outscored banks with an average score of 80 versus 75.2 for banks. As a credit union we scored 86.52! "This list really sets us apart from other financial institu-

tions in our market because it is based on our membership answering a survey that took eight-to-ten minutes to complete," said Keith Kauffeld, president/CEO. "And to make the list we had to have at least 40 evaluations from our members and we had to score 70 points or higher to be considered."

In Nebraska only three credit unions and three banks made the Forbes list. "Consumers are opening their eyes to credit unions in Nebraska and nationwide," said Scott Sullivan, president/CEO of the Nebraska Credit Union League. "The credit union structure being not-for-profit and owned by their members appeals to consumers across Nebraska and it shows in the results of the Forbes survey as well as in credit union membership growth in Nebraska which has increased by 9% over the last five years," said Sullivan.

Kauffeld credits the credit union staff for achieving high marks on the survey. "Our mission is to save our members' time and money." "We are honored Forbes recognized us as one of the top credit unions in Nebraska and in the country, and I credit our wonderful and dedicated staff for always putting the member first."

If you haven't used the credit union's bill pay product the best place to start is to view our demo. You can get to the demo on our website under the menu item "electronic services." The video is easy to understand and is a great resource as you set up your bills.

In addition to paying a bill, this service allows transfers to other financial institutions and person-to-person payments. Person-to-person payments are great when you need to reimburse a family member or even a friend.

It is important to note that you need to have a checking account at the credit union to use bill pay, as well as be enrolled in e-Teller our online banking program. If you don't use bill pay for 90 days the service will be disabled.

Limits have been placed on payment amounts depending on if you are paying a bill to a company or a person and when transferring money. These limits are both for your protection and that of the credit union. To learm more about these limits visit our website and click on "electronic services".
