# Studying Fraud Is Vital in Preventing Fraud

Bill Gates wrote, "We always overestimate the change that will occur in the next two years and underestimate the change that will occur in the next ten." Written almost 30 years ago, his warning against being lulled into inaction still rings true today, and with greater urgency given exponential advancements in technology.

Financial crime skyrocketed in 2024 and promises to get more complex and more devious with criminals exploiting generative Artificial Intelligence (AI). My personal observation is that no one is immune from attack, and preventative tools in use today will be woefully inadequate in just a few years. Criminals are finding new tools and resources making scamming more lucrative and easier than ever. We must be vigilant and act with the same or greater urgency. Consider the following:

- Email 'phishing kits' are available for purchase online.
- Criminals are coding, selling, and purchasing, Software-as-a-Service (SaaS) allowing individuals without extensive technical expertise to scam, exploit or generate fake identities.
- Spelling and grammar errors once easy to spot are obsolete and replaced with flawless messages nearly impossible to detect and socially engineered or personalized to the targeted individual.
- Al-enabled voice mimicking can now replicate anyone's voice with only 3 seconds of recorded material. This Deep Fake allows anyone to script any message they want and make it appear the victim spoke the message, often using it to create an illusion a loved one needs your immediate help.
- "Evil Twin" attacks occur where a cybercrook takes down a legitimate network and briefly replaces it with a network they control capturing passwords and financial data. Public Wi-Fi, such as in an airport, is especially targeted.

If you have an instinct that something isn't right, call us. Do not reply to an email or a text message or click on a link. Do not fall for an alarming call stating you have a large purchase about to be charged to your checking account or credit card. You have rights. You have control over your account. Do not allow yourself to be bullied. When in doubt, disconnect the conversation, and call our published phone number. We're here to help you.

What once took ten years to underestimate the change is now far less. Our credit union business model is based on earning your trust and always acting in your best interests.
