<b>Penalty APR and When it Applies</b>	<b>18.00%</b> This APR may apply to your account if you: <ul style="list-style-type: none"><li>• are over 60 days past due or</li><li>• make a payment that is returned and causes your account to be over 60 days past due.</li></ul> <b>How long will the Penalty APR apply?</b> If your APRs are increased for either of these reasons, the Penalty APR will apply until you make six consecutive minimum payments when due.
<b>How to Avoid Paying Interest on Purchases</b>	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance by the due date each month.
